Approval of Resolution Amendment No. 2017-6 – BASIS Schools, Inc. – amendment to Resolution No. 2016-2 (i) addition of three charter school facilities to the list of projects originally approved in Resolution No. 2016-2 (approving not-to-exceed \$160,000,000 Education Revenue Bonds Series 2016 and/or 2017) and (ii) extending the approval granted therein for an additional 180 days.

Terry Warren briefly described the need for the extension and clarified the proposed projects. He then offered to entertain questions from the board.

Board member **Marcos Garay** motioned to approve Resolution No. 2017-6 as presented. Board member **Jim Keeley** seconded. The Board unanimously approved the motion.
